THE MORT BLOOM AWARD FOR JUDGES, UMPIRES AND RACE OFFICERS

PURPOSE: TO RECOGNIZE EXCELLENCE, COMMITMENT AND DURATION OF JUDGES, UMPIRES AND RACE OFFICERS PLYING THEIR SKILLS IN COMPETITIVE SAILING EVENTS. THE SOUTHERN CALIFORNIA YACHTING ASSOCIATION PRESENTS THIS TROPHY IN HONOR OF MORT BLOOM, AN OUTSTANDING JUDGE WHO REPRESENTED SCYA FOR MANY YEARS IN OUR AREA AND MANY PARTS OF THE WORLD.

NOMINATIONS: YACHT CLUBS WHO HAVE CANDIDATES FOR THIS AWARD ARE TO SUBMIT A RESUME TO THE SOUTHERN CALIFORNIA YACHTING ASSOCIATION. RESUMES SHOULD INCLUDE THE LENGTH OF SERVICE, A BRIEF LISTING OF THE TYPES AND LEVEL OF RACES SERVICED AND ANY UNIQUE SKILLS OR CONTRIBUTIONS THAT HAVE BEEN MADE TO COMPETITIVE SAILBOAT RACING. IN THE ABSENCE OF NOMINATIONS FROM YACHT CLUBS, THE SOUTHERN CALIFORNIA YACHTING ASSOCIATION BOARD OF DIRECTORS MAY ENDEAVOR TO SELECT A CANDIDATE THAT MEETS THEIR CRITERION. CANDIDATES NEED NOT BE MEMBERS OF MEMBER YACHT CLUBS OF THE SOUTHERN CALIFORNIA YACHTING ASSOCIATION BUT MUST HAVE SERVED IN THE SCYA GEOGRAPHIC AREA ON BEHALF OF AN SCYA MEMBER YACHT CLUB AT LEAST ONCE IN THEIR JUDGING, UMPIRING OR RACE OFFICER CAREER. RESUMES MUST BE RECEIVED AT THE HEADQUARTERS OF THE SOUTHERN CALIFORNIA YACHTING ASSOCIATION BY OCTOBER 31ST OF THE CURRENT YEAR.


SELECTION COMMITTEE: THE COMMODORE OR THE COMMODORE'S APPOINTEE SHOULD CONVENE A COMMITTEE WITH EACH HARBOR ASSOCIATION REPRESENTED. THE COMMITTEE SHOULD CONSIST OF EXPERIENCED RACE COMMITTEE PERSONNEL AND, IF POSSIBLE, A PRIOR WINNER OF THIS AWARD. THEY WILL PRESENT A WINNING CANDIDATE TO THE SOUTHERN CALIFORNIA YACHTING ASSOCIATION BOARD OF DIRECTORS IN TIME FOR THE LAST MEETING OF THE YEAR FOR A CONFIRMATION VOTE. THE SELECTION COMMITTEE MAY ALSO DETERMINE THAT A SUITABLE WINNER WAS NOT SUBMITTED FOR THAT YEAR.

PRESENTATION: THE MORT BLOOM AWARD FOR JUDGES, UMPIRES AND RACE OFFICERS WILL BE PRESENTED TO THE SELECTED CANDIDATE AT THE ANNUAL MEETING OF THE SOUTHERN CALIFORNIA YACHTING ASSOCIATION AND/OR OTHER OCCASIONS THAT THE BOARD OF DIRECTORS DEEM APPROPRIATE. THE WINNING CANDIDATE WILL HAVE THEIR NAME ENGRAVED ON A PLAQUE AND AFFIXED TO THE TROPHY. A SUITABLE TAKE HOME TROPHY WILL BE AWARDED AT THE SAME TIME.

TROPHY: THE WINNER OF THIS TROPHY MAY DISPLAY IT AT THEIR YACHT CLUB PROVIDED THAT IT IS LOCATED IN A SECURE PLACE AND THAT THE TROPHY IS INSURED SUFFICIENTLY TO COVER ITS REPLACEMENT IN THE EVENT OF DAMAGE OR DISAPPEARANCE. IN THE EVENT THAT NO SUCH LOCATION IS AVAILABLE, THEN THE TROPHY WILL RESIDE AT THE DEL REY YACHT CLUB IN THEIR TROPHY DISPLAY CASE. THIS TROPHY IS NOT A TAKE HOME TROPHY.

AMENDMENTS TO THIS DEED: THIS DEED OF GIFT MAY BE AMENDED BY A MAJORITY VOTE OF THE SOUTHERN CALIFORNIA YACHTING ASSOCIATION BOARD OF DIRECTORS AND IF AMENDED, SHOULD REFLECT THE SPIRIT OF THIS CURRENT DEED.
